#### 3. Submission Details

#### Please outline your views about the permit application:

Re: Heritage Victoria Permit Application P33108, 28 Clarendon Street, Southbank. Demolition and construction of multi-level buildings

The Royal Historical Society of Victoria's Heritage Committee strongly opposes the above application and urges the Executive Director to reject the application outright.

The Royal Historical Society of Victoria (RHSV) is the peak body representing 340 community historical societies throughout Victoria. It has been active on history and heritage issues since its formation in 1909. The Heritage Committee is accountable to the RHSV Council and has specific responsibility for working with local historical societies to support the preservation of heritage buildings and sites.

The Robur Tea Building is listed on the Victoria Heritage Register (H0526) as significant to the state of Victoria on scientific, architectural and historical grounds. The lengthy citation on the register is evidence of the building's importance. Built between 1887 and 1888, the Robur Tea Building is important scientifically for 'several innovative techniques employed in its construction', namely a system of ironbark piles and concrete rafts to support the construction of a six-storey building on swampy ground. There are no comparable contemporary buildings of this kind because 'such difficult foundations were not tackled again until after WWI'.

Architecturally, the Tea House is significant example of the work of Nahum Barnet, prominent in Melbourne's architectural history for forty years. It is one of the finest examples of a 19th-century warehouse in Melbourne and, indeed, Australia. Further, the Tea House is of seminal historical importance as 'one of the few remaining traces of the industrial and warehousing establishments that until the 1970s and 1980s dominated the south bank of the Yarra', now swamped by luxury apartment developments.

The site is also sensitive and covered by a series of overlays including a Heritage Overlay (HO765), a Design and Development Overlay Schedule 60, and a Parking Overlay Schedule 1.

The proposed development consists of seven office, retail and residential buildings, with the main structure a 25 level tower containing 154 hotel rooms and 20 apartments. The proposed Tea House Hotel would be in excess of 100 metres tall and dwarf the six storey (27 metres tall). Construction of this very tall and intrusive tower would destroy the Tea House's unique landmark status in this area and effectively relegate it to being a façade for retail spaces and food and drinks operations. The proposal 'to create a connection to the new development at every level of the Tea House' would further diminish its landmark standing.

The Heritage Committee finds it particularly disappointing to have to object to a proposal similar to one that was rejected just four years ago. In December 2018, Heritage Victoria rejected a plan to 'adaptively reuse' the Robur Tea House including by building a 24 storey hotel. An ongoing issue is that the Heritage Act does not sufficiently cover issues of curtilage, and the local heritage controls that apply in Southbank, being the same as those for the CBD, are grossly inadequate. This means there is little consideration of the dominating effects of new imposing developments on adjacent heritage buildings.

The Heritage Committee strongly supports the need to 'be respectful of the heritage place' in terms of 'character and appearance, scale, materials, style and architectural expression', and 'Not [to] dominate or visually disrupt the appreciation of the building as it presents to the streetscape'.

We strongly urge that these principles be applied in the case of the Tea House, which should maintain its dominance in this area if its heritage value is to be preserved. We thus urge the Executive Director to reject this application.
